#### **Application requirements**

- Undergraduate degree from an accredited university with minimum GPA 3.00 on a 4.00 scale.
- English test core minimum: IELTS 7.5; TOEFL 100; DET 125; PTE 68 (if you did not graduate from an English-speaking university in a native English-speaking country).
- Official GMAT/GRE score (waivers available).
- International experience.
- Resume documenting professional and academic history.
- Essay answering an application question.
- Contact information for 1 professional or academic reference.
- Admissions interview(s), if applicable.

#### **English Language Program**

This on-campus or online program helps applicants improve their English and receive a TOEFL waiver for admission into the Master of Global Management program. It is suitable for students with minimum IELTS 6.5/ TOEFL 80 who are academically qualified for the MGM.

#### **Bachelor of Global Management (BGM)**

This specialized degree prepares you to compete in a global marketplace through specialized courses like Intercultural Communication, Global Marketing, States and Markets and Organizational Leadership. All students do an international internship and have multiple study abroad opportunities.

#### Bachelor of Science in International Trade (BS)

With such courses as Supply Chain Management for Global Operations, Big Data in the Global Economy, and International Trade and Regional Economic Agreements, this degree prepares you for a career in this growing field, and focuses on the nuances of engaging in trade across borders.

- Conditional admission: GPA 3.00 out of 4.00; TOEFL waiver with completion of the on-campus or online English Language Program (ELP).
- Earned pathway admission: IELTS 5.5 / TOEFL/KiBT 55 / DET 90 / PTE 39.

#### Scholarship opportunities

Thunderbird seeks individuals whose global mindset and personal mission align with our own—and we make generous scholarships available to those whose passion for international management, cultures and world relations is seen in both their words and their actions.

#### **Admission scholarships**

Applicants are automatically considered for a merit scholarship: no separate application is required. The amount awarded increases with GPA and English level:

- Undergraduate students up to \$20,00, renewable for 4 years.
- Transfer students—up to \$14,000, renewable for 2 years.
- MGM students—up to \$21,000 one-off tuition award.

### Thunderbird graduate scholarship

Master of Global Management applicants can complete an additional scholarship request form, including an essay, to be considered.

The scholarship averages \$21,000 and is awarded to those who represent the top group of applicants. Academic background including GPA, GRE, GMAT is also a factor.
