Minimum grade in previous study	3.0 GPA or equivalent
Minimum English level (or equivalent)	IELTS 6.5 / TOEFL 80 / Duolingo 115. If your English level is lower, you can first join Pace's on-campus Graduate Global Pathways program.
GMAT/GRE requirement	Waived for applicants with GPA 3.0+ in all undergraduate coursework. Waived for applicants with borderline GPA 3.0 and either a 4-year bachelor's degree or a 3-year degree from a country listed below. GMAT 510 or GRE 305 required from other applicants. 3-year degrees from these countries only are considered equivalent to a 4-year bachelor's: Australia, Canada, Bangladesh, New Zealand, Pakistan, Bhutan, Nepal, South Africa, Sri Lanka, India (NAAC accredited at B+ or above), and European countries in the Bologna Process
Duration of program	1.5 years (3 or 4 semesters)
Credits	39 credits required to graduate
Tuition	Approximately \$60,840 for full program
Start dates	September, January
